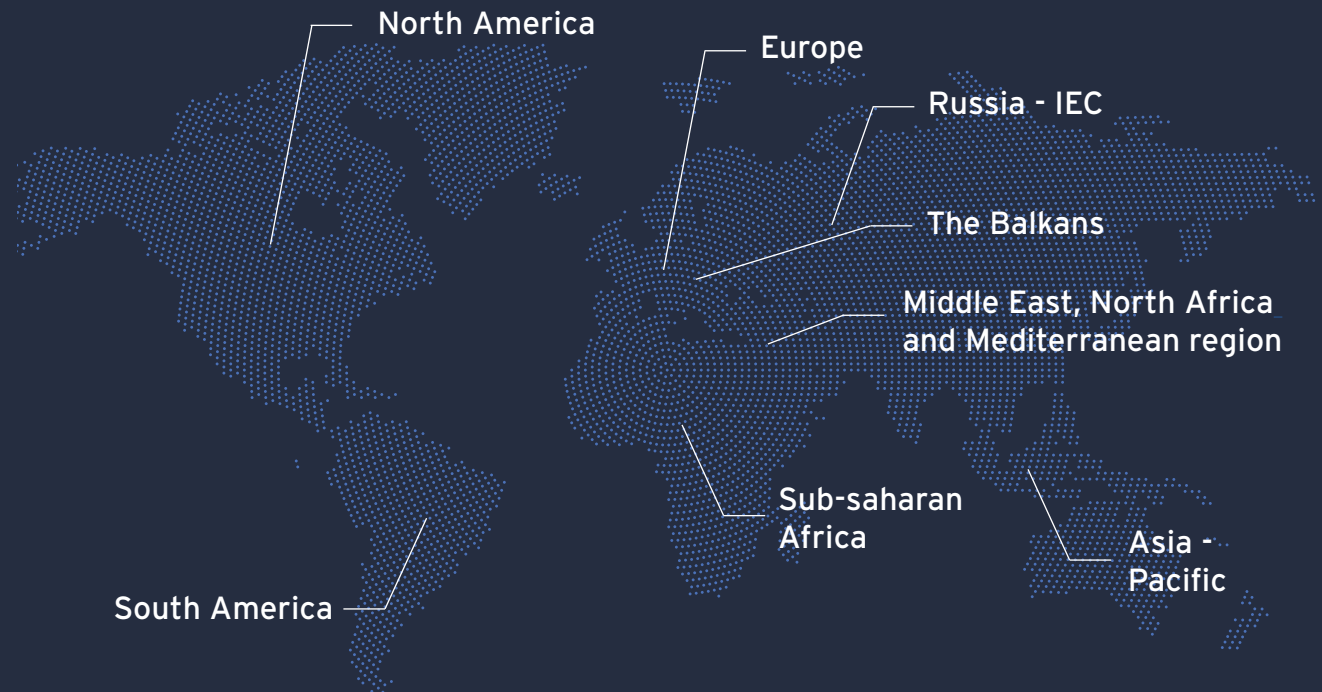

Philippe Steininger is an associate research fellow at the French Institute for International and Strategic Affairs (IRIS). His main areas of expertise are defence policy and aerospace issues.

He joined the French air force in 1980. He graduated in 1983 as an engineer in aeronautics and received his wings of fighter pilot in 1984.

He successively served at the 13th Fighter Wing, as an exchange pilot in the German air force with the 74th Fighter Wing in Neuburg, at the 11th Fighter Wing and as commanding officer of a Mirage 2000 squadron in Cambrai. As a pilot and detachment commander, he participated in many operations in Africa, the Middle East and the Balkans.

In 1999, he was appointed to the Joint Staff in Paris as the United-States and Canada Desk Officer before joining in 2002 the Armed Forces General Inspectorate.

General Steininger was commanding officer of Cazaux Air Base from 2004 to 2007, and later,

head of the NATO/EU Branch of the Delegation for Strategic Affairs, French Ministry of Defence, between 2007 and 2009. From 2009 to 2013, he served in Paris in the cabinet of the Secretary general for defence and national security, being charged with preparing the high-level defence committees.

Back in the air force, General Steininger served as deputy commanding officer, then commanding officer, of the Strategic Air Command.

In 2015, General Steininger was appointed Deputy secretary general for defence and national security and occupied that position till 2018.

General Philippe Steininger is a graduate of the French Joint staff college and attended the 100th Senior course of the Nato Defence College in Rome. He wrote numerous articles on airpower and nuclear deterrence and translated into French John Warden's *The Air Campaign* published in France in 1998. Since 2003, he has been giving lectures on airpower at the Joint Staff College in Paris.

Jean-Marc Vigilant is an Associate Research Fellow at IRIS, specializing in defense issues.

Founder and Chairman of BeVigilant, he advises CEOs of innovative companies with high growth potential in emerging, disruptive and strategic sectors, to develop their activities, including internationally. President of the Euro Défense-France association, he also puts his operational and international experience at the service of European institutions.

A general officer in the French Air and Space Force, Jean-Marc Vigilant is a graduate of the French Air and Space Force Academy, holds diplomas from the French and Spanish War Colleges, and is an auditor at the NATO Defense College in Rome.

Previously Director of the War College in Paris, he adapted the training of future military leaders to the changing strategic environment and new domains of warfare, while strengthening the college's international and European dimension.

In the course of his military career, he has held a wide range of responsibilities, mainly on a joint basis and in an international context, most often at the strategic level in the politico-military field, advising senior French

and allied civilian and military authorities. In particular, he served as an exchange officer in the Spanish Ministry of Defense and as Executive Assistant to the Supreme Allied Commander for Transformation (SACT), NATO's highest military authority in the United States.

At operational level, a fighter pilot by trade, with over 3,000 flying hours and 90 combat missions to his credit, he commanded the 3/33 « Lorraine » fighter squadron in Reims, the 102 « Capitaine Guynemer » air base and the Dijon joint defense base. He also took part in numerous missions and operations in Europe, America, Africa, and Asia, and more recently in the Middle East, where he was the French Senior National Representative responsible for the French armed forces involved in the international coalition in Iraq and Syria, and Director of Civil-Military operations of the Combined Joint Task Force - Operation Inherent Resolve.

French Air and Space Force Major General Jean-Marc Vigilant is an Officer of the Legion of Honor and Commander of the National Order of Merit.

Dr. Pascal Boniface is the founding Director of the French Institute for International and Strategic Affairs - IRIS, based in Paris.

He is the Director of the quarterly journal "La Revue internationale et stratégique" (International and strategic review) since 1991, and the Editor of "L'Année stratégique" (Strategic Yearbook) since 1985.

Dr. Pascal Boniface has published more than eighty books dealing with International Relations, Nuclear Deterrence and Disarmament, European Security, French International Policy, Sport in the International Relations (he developed the concept of *Geopolitics of Sport*) and also the conflict in the Middle-East and its impact in France. Many of them have become classics, reissued on a regular basis and translated in several languages.

Dr. Pascal Boniface publishes numerous articles in international and strategic reviews, is regularly present in the media, national and international, written and audiovisual, and gives many conferences in France and abroad. He's one of the most followed geopolitical analysts on social networks (Facebook, Twitter and TikTok). He also analyses international issues on his own YouTube channel and weekly podcasts "Comprendre le monde" (Understand the world), where he has more than 400 000 followers, as well as on his blog (IRIS, Mediapart and personal).

Pascal Boniface is a member of the National Ethical Commission at the *Fédération française du football* (French Football Federation).

He has been made a Chevalier of the French Award for distinguished services in public and private capacity, Officier of the Legion of honour and Chevalier of the Order of the Arts and the Letters.

Ophélie Coelho is an Associate Research Fellow at IRIS where she contributes to the work of the Geopolitical Observatory of Digital and Emerging Technologies.

She is the author of *Géopolitique du numérique : l'impérialisme à pas de géants* (Les Éditions de l'Atelier, 2023), in which she examines the rise of global technology companies and their role in the reconfiguration of power.

Her academic background - a Master's 2 in International Relations, complemented by studies in the history of science and the sociology of technology - combined with solid professional experience in the IT industry, has nurtured a resolutely interdisciplinary approach.

She is currently working on a thesis entitled "Connection Points, Fault Lines: digitalization as a vector of power change and systemic risks in Southern Africa", which extends the reflections developed in her book. In particular, she uses the concepts of nodal power, structural power and chains of dependence to examine the effects of digital transformations on regional balances of power, forms of state sovereignty, and the asymmetries induced by private control of infrastructures that have become essential.

Romuald Sciora is a French-American Associate Research Fellow at the IRIS and director of the Political and Geostrategic Observatory of the United States. A political analyst, author, and documentary filmmaker, he is a recognized specialist in the United Nations and in American foreign and domestic policy.

As a writer, he has published, among many others, four books on the UN and an essay on the UN General Assembly. As a filmmaker, he has produced a dozen political documentaries, including a TV series devoted to the United Nations, broadcast in more than 20 countries.

He is the only person to have had the opportunity to meet and interview several times all of the UN Secretaries-General, from Kurt Waldheim to Ban Ki-Moon.

He has been living in the United States for nearly 20 years. From 2011 to 2016, he served as President of the French-American Global Forum, a not-for-profit organization based in Washington, D.C. On this occasion, he co-organized and led a large number of conferences and seminars with the European Union, research centers such as CSIS and the Brookings Institution, *The New York Times* and magazines such as *The Atlantic*,

*Newsweek* and *Foreign Affairs*. Till 2019, he was the host of *Le monde diplomatique* Debates, an international program of conferences sponsored by the famous French monthly *Le monde diplomatique*.

He works regularly with universities such as New York University, American University in Washington and University of Quebec in Montreal and as a consultant for different institutions and NGOs. He also appears regularly in the media, whether in North and South America, Europe, Russia or the Middle East, to comment on international news.

His latest books, *Who Wants to Kill the U.N.?*, co-written with Anne-Cécile Robert, *Poor John - America in the Time of COVID-19*, *Valiant Woman*, *Should we be afraid of wokisme ?* and *A Shattered America* were published in 2018, 2020, 2021, 2023 and 2025. In the meantime, the complete collection of his interviews with UN Secretaries-General was published in a special issue of *The International Politics Reviews* dedicated to his work.

His last book, *Utopies made in Monde, le sage et l'économiste* (éditions Odile Jacob) has been published in 2021.

Georges Lefeuvre is an associate research fellow at IRIS. Former political attaché to the European Commission in Pakistan (2002-09), he is a specialist in the Afghanistan-Pakistan-India crisis arc. He is also an independent consultant and teaches at IRIS Sup'.

Anthropologist and linguist (University of Haute Bretagne and Associate Research Fellow at the Contemporary anthropology laboratory of Professor Jean Arlaud, University of Paris-Diderot, until 1988), Georges Lefeuvre has spent six years in the Kalash tribe, at the Afghan-Pakistani border, between 1971 and 1987. Author for the University of Haute Bretagne (DEA 1990) of the linguistic description of their language (Kalasha, a rare language - 4,000 speakers - of ancient Indo-European), he also compiled an unpublished dictionary with 6,000 entries and references to Sanskrit.

From 1987 to 1989, he was deputy director of a French NGO based in Peshawar and traveled extensively in Afghanistan. From 1989 to 1993, he directed the Alliance Française of Peshawar and developed a cultural center for French-speaking Afghan refugees (PCFA). As the cultural attaché to the French Embassy in Uzbekistan from 1993 to 1997, he created the Alliances françaises of Tashkent and Samarkand and assisted Professor Pierre Chuvin in the creation of the French Institute for Central Asian Studies (Iféac). Back in Pakistan, he was the cultural

attaché at the French Embassy from 1997 to 2001, before joining the European Commission Delegation to Pakistan as a political attaché in 2002. For 8 years, he devoted himself to research and wrote numerous analyses for the European Union on the various factors of regional instability and more particularly the Pashtun border insurgencies between Pakistan and Afghanistan, the sociology of terrorist networks and the exogenous ideologies that irrigate them.

In addition to his contributions to collective works (*Le Mondial des nations* - Choiseul 2011; *L'Afghanistan, gagner le cœur et les esprits* - Presses Universitaires Grenoble 2011; *L'Année stratégique 2015* - IRIS), he has written analyses for the French Ministry of Foreign Affairs and has led numerous national and regional sessions for the IHEDN. He regularly publishes in *Le Monde*, *Le Monde Diplomatique*, *Le Temps*, *La Croix*, *Diplomatie Magazine* and occasionally in *National Geographic* (2001), *Géo* (2002), *Critique Internationale* (Ceri, 2002). He regularly participates in round tables and is a regular guest on television and radio.

Karim Emile Bitar is an associate research fellow at IRIS and Editor of French monthly public affairs magazine L'ENA hors les murs. He is an Associate Professor of International Relations at Lebanon's Université Saint-Joseph (USJ), an Associate Fellow at the Geneva Center for Security Policy (GCSP) and a Research Associate at Brussels' Institut Medea. He is a Professor of International Relations and of History of Political Thought at several French Grandes Ecoles.

He gave conferences and keynote addresses in more than 20 countries. In the past 10 years, he has been quoted more than 1200 times in the international media. He frequently testifies before the Foreign Affairs Committees of the French and European Parliaments.

Besides his academic and research activities, Karim Emile Bitar is a consultant in management, communication and public affairs (KB Consulting Group). He worked for five years at France's television channel CANAL+ (Vivendi Universal) as a manager in charge of strategic planning, business development and external relations.

He graduated from France's National School of Administration (ENA, promotion Cyrano de Bergerac 1997-1999) and from the Paris Institute of Political Studies (Sciences Po). He also studied Law at the University

of Paris Sorbonne and obtained a Bachelor of Arts (Economics and International Relations) from McGill University. He spent his senior year at Harvard where he studied Government and specialized in Middle East Studies.

He edited and co-wrote the collective book *Regards sur la France* (Seuil, 640 pages), in which thirty personalities from across the world (former heads of state, intellectuals, political scientists, economists, artists and heads of multinational firms) analyzed France's strengths and weaknesses.

He has also authored numerous book chapters and articles in leading publications including *Le Monde diplomatique*, *Libération*, *Le Monde*, *Informed Comment*, *Atlantico*, *La Vanguardia*, *An Nahar*, *L'Orient-Le Jour*...

He is Vice-President of the Circle of Arab Economists, the secretary general of the Emile Bitar Foundation, a member of the managing board of the 'Débats d'Agorena' and of the 'Lundis de l'ENA' Club.

# GEORGES LEFEUVRE

Georges Lefeuvre is an associate research fellow at IRIS. Former political attaché to the European Commission in Pakistan (2002-09), he is a specialist in the Afghanistan-Pakistan-India crisis arc. He is also an independent consultant and teaches at IRIS Sup'.

Anthropologist and linguist (University of Haute Bretagne and Associate Research Fellow at the Contemporary anthropology laboratory of Professor Jean Arlaud, University of Paris-Diderot, until 1988), Georges Lefeuvre has spent six years in the Kalash tribe, at the Afghan-Pakistani border, between 1971 and 1987. Author for the University of Haute Bretagne (DEA 1990) of the linguistic description of their language (Kalasha, a rare language - 4,000 speakers - of ancient Indo-European), he also compiled an unpublished dictionary with 6,000 entries and references to Sanskrit.

From 1987 to 1989, he was deputy director of a French NGO based in Peshawar and traveled extensively in Afghanistan. From 1989 to 1993, he directed the Alliance Française of Peshawar and developed a cultural center for French-speaking Afghan refugees (PCFA). As the cultural attaché to the French Embassy in Uzbekistan from 1993 to 1997, he created the Alliances françaises of Tashkent and Samarkand and assisted Professor Pierre Chuvin in the creation of the French Institute for Central

Asian Studies (Iféac). Back in Pakistan, he was the cultural attaché at the French Embassy from 1997 to 2001, before joining the European Commission Delegation to Pakistan as a political attaché in 2002. For 8 years, he devoted himself to research and wrote numerous analyses for the European Union on the various factors of regional instability and more particularly the Pashtun border insurgencies between Pakistan and Afghanistan, the sociology of terrorist networks and the exogenous ideologies that irrigate them.

In addition to his contributions to collective works (*Le Mondial des nations* - Choiseul 2011; *L'Afghanistan, gagner le cœur et les esprits* - Presses Universitaires Grenoble 2011; *L'Année stratégique 2015* - IRIS), he has written analyses for the French Ministry of Foreign Affairs and has led numerous national and regional sessions for the IHEDN. He regularly publishes in *Le Monde*, *Le Monde Diplomatique*, *Le Temps*, *La Croix*, *Diplomatie Magazine* and occasionally in *National Geographic* (2001), *Géo* (2002), *Critique Internationale* (Ceri, 2002). He regularly participates in round tables and is a regular guest on television and radio.

Georges Lefeuvre is an Officer of Arts and Letters (2000).

Lukas Aubin is a Senior Research Fellow at IRIS, in charge of the Sport and geopolitics programme, specializing in the geopolitics of Russia and sport.

Doctor of Slavic Studies (University of Paris Nanterre - University of Paris Lumières), holder of a double Franco-Russian Master's degree in geopolitics of the post-Soviet space at the Russian State University of Human Sciences (RGGU) (Moscow, Russia) and at the French Institute of Geopolitics (IFG) of the University of Paris 8 (Paris, France), he defended a thesis entitled "The Sportokratura in Russia: governing through sport in the era of Vladimir Poutine, 2000-2020", the book adaptation of which was published by Bréal in May 2021.

Russian-speaking and a seasoned traveler, he has traveled the former USSR for more than a decade to conduct his work. His research focuses mainly on the new geopolitical issues of Russia and sport. He is also interested in the question of sovereignty within the post-Soviet space. He regularly speaks at conferences and seminars on these issues, as well as in various media.

He has taught history and geopolitics at the Universities of Paris-Nanterre, Versailles Saint-Quentin en Yvelines, and Rennes 2.

His second book "*Geopolitics of Russia*" was published by La Découverte in August 2022.

Arnaud Dubien's main areas of expertise are Russian foreign policy, Russian circles of power, Franco-Russian relations, as well as Russia's policy in Africa.

*d'études comparatives Est-Ouest* and *Diplomatie*. Arnaud Dubien is a regular contributor to French-language media (*Le Figaro*, *L'Opinion*, *RFI*, *RTS*, *Radio Méditerranée internationale*, etc.) and Russian media (*Kommersant*, *Vedomosti*, *Nezavissimaïa gazeta*, etc.).
